- Determine the services required and guide the approved Service Provider to direct relevant vehicles to respective service bays or facilities.
- **5** When the vehicles are ready for the customers to monitor, assemble them in the showroom area. Assist in marketing and attract international buyers to fix sales.
- 6 Arrange the on carrier with a shipping line when the vehicle is ready for loading.
- 7 Ensure the BL as per the sales arrangement.
- 8 Re-export vehicles within 06 months from arrival date
