HAMBANTOTA INTERNATIONAL PORT GROUP (PRIVATE) LIMITED (HIPG) invites sealed tenders from suitably qualified parties for the Design and Construction of the Gate 10B Complex at the Port of Hambantota.

The project involves the development of a dedicated **Import Out-Gate Facility** to improve import cargo exit operations, reduce congestion, segregate traffic movements, and enhance customs, security, and operational control.

The Works include the **design, approvals, construction, supply, installation, testing, commissioning, and handover** of the Gate 10B Complex, comprising gate buildings, guard/sentry facilities, reinforced concrete canopy, roads and pavements, four (04) weighbridge systems, lane selection gate, VMS display, utility services, drainage and sewerage systems, water and fire-water connections, electrical works, HVAC, traffic management facilities, external works, fencing relocation, landscaping, and all associated civil, electrical, mechanical and ICT provisions, including training and as-built documentation.

Tenderers shall submit **lump sum fixed price offers** and shall have:

- Minimum **three (03) years' experience** in similar construction works; and
- Minimum **annual turnover of USD 2,500,000**.

Local Tenderers shall possess a valid **CIDA Registration for Building Construction with minimum Grade C1**. Foreign Tenderers shall confirm their commitment to obtain temporary CIDA registration as required. **Joint Ventures and Consortiums shall not be accepted**.
